B. Approval Condition

1. Application & Limitation

1) The materials used for valve body, etc as appropriately are to be supplied by the approved manufacturers, and certified by the Society or to be satisfactory to the Surveyor.

2) Gaskets and packings are to be suitable for the condition of use and to have a construction specified in Korean Industrial Standards or equivalent construction thereto.

2. Individual Product Cert. and Drawing Approval Requirement

1) Individual Product Certification is required.
2) The minimum average energy for Charpy V-notch impact test should be complied with the relevant requirements of the Rules, Pt. 7, Ch. 5.

The following tests are to be applicable for each size of the valves as individual product certification.

- Hydrostatic test of the valve body at a pressure equal to 1.5 times the design pressure - Cryogenic testing consisting of valve operation and leakage verification for a minimum of 10% of each type and size of valve for valves

- Proving testing at ambient temperature consisting of leakage test at a pressure equal to 1.1 times the design pressure

1) The product is to be permanently marked with manufacturer name and type designation on a suitable position.
